To Whom It May Concern,

After reviewing your student's current grades for this year, it appears that he/she may have to repeat some of the required courses necessary for your student to graduate on time or successfully achieve at the next grade level. Attached is information regarding a summer credit recovery program that will be available to Blissfield High School students. For managing reasons, seventy students will be the maximum number of students who can enroll in the summer school program. Enclosed you will find your student's transcript with highlighted courses that your son/daughter still needs to earn credit for, as well as a registration form for summer school credit recovery courses. The transcripts provided do not include second semester grades. If your student needs additional classes after grades for the second semester have been posted, you will be contacted. Also listed below are additional credit recovery programs that are offered in the area and online.

Students will be able to take two credit recovery classes to start. If both classes are complete by week four (7/9/21), they will be able to register for a third class with no registration/fee needed. Please email Mrs. Covell at ccovell@blissfieldschools.us by 7/12/21 with which course the student would like to enroll in for the third class. All classes will need to be finished before the August 13th deadline and no extensions will be given.

****For students who are new to Edgenuity online classes, a mandatory orientation will be held on Wednesday, June 16th at 10am via Google meet to answer any questions they may have and to help the student navigate through the program. The teacher of record will contact these students via email to set up the Google meet. If your student has previously taken an Edgenuity online class, orientation is not required and they can start classes after registration.**
