Blissfield Community Schools is eligible to receive funds through the 98c Federal Grant to address learning loss following the COVID-19 pandemic.

98c Grant Overview

Per Pupil Allocation

Each district is eligible for \$50 per student. This equates to approximately \$55,000 for BCS.

Funds


Funds must be used to address learning loss during the 2022-23 school year.


Presentation

The plan must be presented to the Board of Education by October 30, 2022 and the application submitted to MDE by November 30, 2022.

Accountability

The plan must include how the impact will be measured, and the outcomes must be reported to the legislature by July 14, 2023.






A need was identified to support learning loss for 4th, 5th, and 6th graders who were found to be in the bottom 20th percentile in reading and/or math according to fall 2022 benchmark assessments.

These students were affected by the pandemic shut down when they were 1st, 2nd or 3rd graders in 2020 and the following two school years post shut-down. The challenges imposed by the pandemic on education impacted these learners during a crucial time in their development of foundational reading and math skills.

Our goal is to ensure that these students have a firm foundation in reading and math as they progress forward.



Identified students will be invited to attend the "Royal Learners" after school intervention program in reading and/or math.

- Program starts January 2023
- Two days per week (T/Th)
- One hour per session
- Approximately 18 weeks
- Foundational skills taught using evidence-based methods
- Certified teachers and/or highly qualified aides trained in program
 - -implementation
- Snacks provided
- Transportation provided



October 2022: Present plan to BCS Board of Education

November 2022: Upon approval by board, apply for 98c Grant


November 2022: Recruit and hire instructional staff; Invite eligible students

December 2022: Train instructional staff in evidence based intervention programs

January 2023: Begin interventions with students

May 2023: Program concludes

July 2023: Report achievement outcomes to legislators
