They stated that some parents may have health issues that the vaccine will not work on preventing them getting covid and really stressed that they would like to see the Board change their position currently, and require masks until a vaccine becomes available for the younger students. They both feel very strongly that masks do work in helping eliminating the spread of this virus.

Superintendent Riley informed the Board that he is currently looking into the option of possibly having available a virtual option for Board meetings for individuals that may wish to participate without having to be in person at the meetings. The Board does not see a problem with this option and he will look further into it. TowerPinkster will be giving an update to the Steering Committee at the end of August, with a presentation to the Board in September. A meeting with the pupil accounting auditor is being held Wednesday to review the new MDE requirements for virtual classes, as the rules had been changed last year during the pandemic and are now going to be stricter on information needed for each student. Trying to get local data on the virus from the Health Department has been quite difficult. He will continue trying to get this data, as District level decisions will be based upon this data.
